ORDER GRANTING EXTENSION OF TIME

This matter came before Uday V. Joshi, the State Engineer's designated Hearing Examiner, upon the Catron County Board of County Commissioners' and John and Helen Hand and the Hand Living Trust's Unopposed Motion for Extension of Deadlines (Motion), filed on October 25, 2017.


Having considered the matter, the Hearing Examiner finds that the deadlines for Disclosure of Witnesses and Disclosure of Exhibits and other related deadlines, set forth in the August 10, 2017 Scheduling Order be extended:

Therefore, the Motion is granted and the following deadlines are adopted:

- 1) The deadline for Applicant APR to disclose its witnesses is extended from October 27, 2017 to January 26, 2018.
- 2) The deadline for the Water Rights Division and Protestant Parties to disclose their witnesses is extended from December 22, 2017 to March 22, 2018.
- 3) The deadline for Applicant APR to disclose its exhibits is extended from March 28, 2018 to June 28, 2018.
- 4) The deadline for the Water Rights Division and Protestant Parties to disclose their exhibits is extended from July 25, 2018 to October 25, 2018.
- 5) The deadline for Applicant APR to disclose its rebuttal witnesses and exhibits is extended from November 14, 2018 to January 25, 2019.
- 6) The deadline for leave to file sur-rebuttal witnesses or exhibits is extended from December 21, 2018 to February 19, 2019.
- 7) The deadline for the close of discovery is extended from February 13, 2019 to March 25, 2019.

All other dates and provisions of the August 10, 2017, Scheduling Order remain unchanged.


